Morning Review

Good morning, team!

In the U.S. stock market, Institutional & Large Investor Placement has long been a common capital market practice. This model typically appears in IPOs (Initial Public Offerings), SPAC financings (Special Purpose Acquisition Companies), Follow-On Offerings, and PIPE (Private Investment in Public Equity) transactions. The goal is to provide stable funding for companies, reduce



market uncertainty, and allow institutional investors and high-net-worth individuals to secure early allocations of high-quality assets.

In U.S. IPOs, underwriters (such as Goldman Sachs and JPMorgan) allocate shares based on investor type, capital strength, and existing holdings through a process known as “demand-based allocation.” This means institutional investors, funds, and large investors always get priority access to new shares, while retail investors face extremely low allocation rates, often seeing their shares further diluted by large institutional placements. This pattern has been repeatedly confirmed in past IPOs, with Airbnb (ABNB) being one of the most notable examples.

In December 2020, when Airbnb went public, institutional investors subscribed to 75% of the IPO shares. Due to overwhelming market demand, Airbnb had to raise its IPO pricing range from \$44-\$50 to \$68 before listing. Even with this adjustment, institutional funds rushed in, securing the vast majority of the allocation. As a result, Airbnb opened at \$146 and surged over 115% on its first trading day. Meanwhile, institutional shares were subject to a six-month lock-up period, preventing short-term selling and ensuring market stability.



The MDHT Large Investor Allocation mechanism is highly similar to this model, adopting the same institution + large investor allocation strategy. This ensures that core investors receive 100% of their allocated tokens, without facing the low winning rate competition seen in public subscriptions. However, there is one key difference, GSC Large Investor Allocation participants have no lock-up restrictions! And the result? Weak market demand, an immediate drop below the IPO price at the open, and a closing price of \$34.82, down 8.4% from its \$38 offering price. Its post-IPO performance was disastrous, with no institutional support to back its market value.

Why did this happen? Because institutional capital is the key to an IPO's success! If institutions aren't willing to step in, market confidence collapses, and new shares face massive selling pressure after listing. In the U.S. IPO market, retail investors are almost always diluted by institutions, and only a small fraction of them can buy new shares at the offering price. Meanwhile, the



impact of Large Investor and Institutional Allocations far exceeds what most retail traders realize.

✦ Institutional capital determines IPO stability, while excessive retail allocation increases the risk of breaking below the offering price!

✦ Robinhood's failure proved how critical institutional backing is for market stability, while MDHT's institutional allocation selling out instantly is the strongest possible signal!
